# What is the Procurement and Contract Management Foundations course?

This course is one of eight **Public Works Foundations Program** courses curated by IPWEA Victoria to develop the skills of public works professionals in key responsibility areas. Each course comprises four 4-hour sessions presented over consecutive weeks.

### **Course Overview**

Transparent procurement and effective contract management are vital components of project management. This course introduces key concepts and provides a foundational-level overview of best-practice procurement methods and contract management approaches.

- Choosing the right Contract type
- Establishing evaluation criteria, weighting and what you want the tenderer to tell you
- Evaluation processes and steps to ensure probity and transparency of the process
- Assessment of conforming/non-conforming tender submissions and contract departures
- How and when to negotiate with a tenderer and how to manage the interview process
- Preparing the evaluation report with recommendations for award
- Preparing the Contract for execution
- Contract Management principles
- Roles and responsibilities of the key personnel involved in managing a contract
- Contract Administration versus Contract Management versus Contractor Management
- Key components and stages of the Contract
